Action & Resolution of the board of supervisors of Greene County forming new term.

At the annual meeting of the board of supervisors of the County of Greene held at the Court house in the Village of Catskill in said county on the 14th day of November one thousand Eight hundred & forty nine

Present

Amos Botsford Supervisor of the town of Greenville and Chairman of said Board

Jacob Roggen, Supervisor of the town of Durham; Howland Macomber, Supervisor of the town of Windham; David B. Strong, supervisor of the town of Ashland; Bethuel Sutherland, supervisor of the town of Prattsville; Jacob Hagaboon, supervisor of the town of Lexington; Fisk Beach, supervisor of the town of Hunter; Jacob Van Orden, Supervisor of the town of Catskill; Alonzo Greene, Supervisor of the town of Athens; Augustus Cornwall, Supervisor of the town of Coxsackie, Garret Coonley, Supervisor of the town of New Baltimore; Amasa Keith, Supervisor of the town of Cairo.

Application having been made to this Board pursuant to an act of the Legislature passed on the 3rd day of April 1847 entitled an act to Vest in the board of Supervisors certain Legislative powers and to prescribe their fees for certain services by twelve freeholders & more in Each of the towns of Lexington & Hunter to Erect a new town from said towns of Lexington & Hunter. Such application was referred to a committee appointed by the Chairman of said board of supervisors consisting of Daniel B. Strong, Supervisor of Ashland; Augustus Cornwall, supervisor of Coxsackie and Bethuel Sutherland, Supervisor of Prattsville, and that they report with all convenient speed to this board their opinion and decision in reference to said

application. And several of the inhabitants and freeholders of said towns of Lexington & Hunter having presented to this board a petition asking for the Erection of a new town from the said towns of Lexington & Hunter, And several remonstrances having also been presented by several of the inhabitants & freeholders of said towns of Lexington & Hunter remonstrating against the Erecting of said new Town which petitions & remonstrances were referred to said Committee. And it also appearing to the board by affidavits that a notice in writing of the application aforesaid for the Erection of a new town from said towns of Lexington & Hunter, Subscribed by twelve freeholders of Each of said towns had been posted in five of the most publick places in Each of said towns of Lexington & Hunter for four weeks next previous to said application to this board And it also appearing by affidavits that a copy of such notice had also been published for at least six weeks immediately before the meeting of this board at which such application was to be made in all the newspapers printed in the County of Greene to wit in a paper printed in the Village of Catskill called the Recorder and Democrat in the paper printed in said Village heretofore called the Catskill Messenger and now the Greene County whig and also a paper printed in the town of Prattsville in said County called the Prattsville Advocate which said affidavits & notices were referred to the aforesaid Committee appointed in the subject of said Application and the Petitioners for said application have also presented to this board a map & survey of said towns of Lexington & Hunter being all the towns affected by said application which map & survey are also referred by the said board to the aforesaid Committee.

The Committee to whom said application was referred as aforesaid did on this 16th day of November one thousand Eight hundred & forty nine Report to this board that they had only Examined the subject referred to them for the Erection of a new town from parts of the towns of Lexington & Hunter and are unanimously of opinion that the petitioners have Complied with all the provisions of the aforesaid act & that a new town ought to be Erected from parts of the towns of Lexington & Hunter & that the following should be the boundaries of such new town. Beginning at the northwest corner of the town of Hunter & being the north East corner of the town of Lexington on the South boundaries of the town of Windham in said county & on the dividing line between Great lots numbers twenty two & twenty three Hardenburgh patent & runs thence along the division line between the towns of Windham & Lexington Westerly to the South East corner of the town of Ashland in said County and along the division line between the towns of Lexington & Ashland westerly to the west line of Great lot number twenty two aforesaid thence along said west line aforesaid Southerly to the southwest corner of lot number sixty nine of that part of Great lot number twenty two aforesaid known as the south township thence along the south line of said lot number sixty nine and the south lines of lots number seventy seventy one and seventy two the East lines of said lot seventy two south line of lots number ninety two ninety South & East line of lot number Eighty Eight South lines of lots numbers Eighty seven & Eighty five os said township to the north west corner of that part of the town of Lexington recently set off from the town of Hunter being on the west line of Great lot number twenty three aforesaid and the southwest corner of lot number seventy six of said Great lot thence along the south lines of said lots number seventy six seventy seven & seventy Eight being also the dividing line between the towns of Lexington & Hunter Easterly one hundred and twenty Eight chains thence crossing said lot number seventy Eight North thirty four degrees thirty minutes East sixty Chains to the Southeast corner of lot number seventy one and in the same direction along the East line of lots numbered seventy one six sixty three fifty Eight & fifty three of said Great lot number twenty three to the southwest corner of lot number forty nine of said Great lot thence along the South & East lines thereof and the north line of lot number fifty to the west line of

Resolved that the first annual town meeting in the new town hereby Erected shall be held at the house of Silas Greene in the now town of Lexington on the first Tuesday of April next and that Fisk Beach, S.B. Hinman & Alfred Peck three Electors of such new town whose duty it shall be to preside at such meeting and that a notice of the time & place of such meeting be signed by the Chairman or clerk of this board to be posted in four of the most publick places in said town by the persons or Electors designated as aforesaid to preside at such town meeting at least fourteen days before holding the same

Resolved That the place for holding the first town meeting hereafter to be held in the town of Lexington shall be at the house of Lucas VanVaulkenburgh in the said town of Lexington and the place for holding the first town meeting in the town of Hunter shall be at the house of William E. Anthony in said town of Hunter

Name Change

January 27th 1813, the territory of Windham was divided and three towns erected from it. These were Greenland, embracing all that part lying east of the easterly line of Great lot No. 22 in the Hardenburgh Patent and south of the height of land between the East Kill and Big Hollow; the new town of Windham, embracing that part which lay north of the ridges between the East Kill and the Great Hollow and between Batavia and the South Mountain settlement; and New Goshen containing all the remaining part of old Windham, that is the eastern part. The name of New Goshen was changed to Lexington, March 19th 1813, and Greenland was changed to

Hunter, in honor of John Hunter, an early proprietor in the Hardenburgh Patent, April 15 th 1814.
