# <u>October 1, 2019</u> <u>Town of Lexington Town Board Public Hearing</u> Snowmobile and ATV Laws for 2019

Supervisor Berger opened the public hearing at 6:00 PM at the Municipal Building, 3542 Rte. 42, Lexington.

Supervisor Berger started the public hearing by saying that the purpose of the hearing is designating Town highways for travel by snowmobiles and designating Town Highways for travel by ATVs. Lucy Veneski asked if this would affect private roads and the answer was no. She asked if the atvs would be allowed to ride up and down the road. Typically people would be traveling to and from a destination. Bob Murphy asked if snowmobiles would be open to the public or just for the people in Lexington. Supervisor Berger read the snowmobile law aloud. Bob Murphy then asked if the Town Highway department would maintain the shoulders of the roads for snowmobiles and Supervisor Berger said no. Glen Howard said that the snowmobile club would maintain them and asked if the Town could wing the top of the snowbanks. Bob Murphy was worried about his driveway being torn up, but the snowmobile law is specific to which Town Roads and where on those roads snowmobiles are allowed to go. Bob Sainato said that the fear of large numbers of people coming to Lexington to ride snowmobiles can't happen. Strangers will not come here to ride the roads because there is no place for them to park. The trails will be marked. Anne Hall said that people use their atvs on the road she lives on and rides them up and down the road for hours. She has asked them to ride in the other direction and not by her house. She does not want to be the bad guy, but they are loud and give off exhaust fumes. She is also worried about children driving these vehicles. Glen Howard said that there are snowmobile safety courses that are given. Lynn Byrne said that there is a big difference between snowmobiles and atvs. There is no way to police the atvs. If the atv law is passed it states 20 mph and along side the road .Bob Sainato said that people need to comply and that it would be safer & easier to police if there is a law. Bob Murphy doesn't want to have to be policing atvs and snowmobiles and does not want this area turned into a recreational site. Chago Betes said you need to be a Town resident. Lynn Byrne wanted to know if there is any way to identify people that are non compliant. Bob Sainato said that he has to register with the Town and will get a sticker. The Town would have records of who has what number. Sal Mancuso Jr. said that people will respect the laws and not abuse them. When there is no structure there are more problems. Glen Howard spoke to the Town of Roxbury and they have over 20 miles of trails alongside their roads. Bob Murphy was worried about being liable if someone gets hurt on his property. Town Attorney, Tal Rappleyea said that anyone can sue but there is assumption of risk and the property owner is not liable. There has to be gross negligence. John Falke said that it is a privilege and that since most people know each other they can police themselves. Lucy Veneski does not want to have to absorb the cost of lawsuits. Council Member, Bradley Jenkins asked about UTVs and Golf Carts and Town Attorney, Tal Rappleyea responded by saying that there is no authority under New York State. Roger Shoemaker said that his 90 year old wife uses an ATV on their property which has been in their family for 123 years. He was concerned about having to pay for a Town registration, but it is not needed if you are staying on your property. Supervisor Berger asked if there were any other comments and with none Council Member, JoEllen Schermerhorn made a motion to close the Public Hearing which was seconded by Council Member William Pushman and with no one opposed the Public hearing was closed at 6:50 PM.

## October 1, 2019 Town Board Meeting

Supervisor Berger opened the regular Town Board Meeting at 6:50 P. M. followed by the Pledge of Allegiance to the American Flag. There was a moment of silence in memory of Marguerite Sperbeck.

Town Attorney, Tal Rappleyea said that he would go over the Environmental Review. It is a 2 part review. He asked 11 questions that were all answered no, which means that there would not be negative environmental impact.

#### ATV and Snowmobile Laws for 2019

On a motion by Supervisor Berger, seconded by Council Member, William Pushman the following was,

ADOPTED: Ayes - 5 - Barcone, Berger, Jenkins, Pushman, and Schermerhorn Nays - 0

Therefore, this Town Board adopts Local Law No. 4 of 2019, Designating Town Highways for Travel by ATVs and Local Law No. 5 of 2019, Designating Town Highways for Travel by Snowmobiles. The Laws are as follows;

### Local Law No. 4 of 2019 Designating Town Highways for Travel by ATVS

Be it enacted by the Town Board of the Town of Lexington as follows:

SECTION 1. Purpose and Authority

The Town Board of the Town of Lexington has determined that it is appropriate for ATVs (All-Terrain Vehicles) to access certain areas and/or trails adjacent to certain Town Highways and deems it appropriate to designate certain Town Highways for travel by ATVs.

The New York State Vehicle and Traffic Law 2405 authorizes municipalities to post and designate certain highways within such municipalities for travel by ATVs (All-Terrain Vehicles), as defined in 2281 of the Vehicle and Traffic law and the Town Board of the Town of Lexington shall hereby exercise such authority.

### SECTION 2. Town Highways Designated for Travel By ATVs

- a) All Town Highways shall be and hereby are designated for travel by ATVs.
- b) The Highway Superintendent shall post such Town Highways with signage indicated such designation as soon as practicable after the enactment of this local law in accordance with the rules and regulations of the New York State Department of Transportation.
- c) A copy of this local law shall be filed with the Commissioner of the New York State Department of Transportation.

#### **SECTION 3. Rules and Requirements**

All persons traveling by ATV on Town Highways must:

- a) Be a resident or property owner or accompanied by a Town resident of property owner within the town and obtain a permit from the Town Clerk on a form prescribed by the Town with a fee set by resolution of the Town Board;
- b) Be at least 16 years of age and possess a valid drivers' license;
- c) Operate only a registered ATV on which a safety triangle must be displayed on the rear thereof;

- d) Wear a helmet at all times
- e) Operate only on the shoulder of the designated roads and not in the vehicle lane;
- f) Operate such ATVs no faster than 20 miles per hour;
- g) Operate only between Sunrise and Sunset, Eastern Time;
- h) Abide by all NYS Vehicle and Traffic Laws;
- i) Not trespass on any private land and must obtain permission from any landowner to operate an ATV on such property

#### SECTION 4. When Effective

This local law shall take effect immediately upon filing with the Secretary of State's Office.

### Local Law No. 5 of 2019 Designating Town Highways for Travel by Snowmobiles

Be it enacted by the Town board of the Town of Lexington as follows:

SECTION 1. Purpose and Authority

The Town Board of the Town of Lexington has determined that it is appropriate for snowmobiles to be operated on certain Town Highways and deems it appropriate to designate such Town Highways for travel by Snowmobiles.

The New York State Parks, Recreation and Historic Preservation Law 25.05 and 25.09 authorize municipalities to post and designate certain highways within such municipalities for travel by snowmobiles and the Town Board of the Town of Lexington shall hereby exercise such authority.

SECTION 2. Town Highways Designated for Travel by Snowmobiles

a) The following Town Highways shall be and hereby designated for travel by snowmobiles:

- i Jaeger Road;
- ii Beech Ridge Road South, from West Kill starting at the Route 42 intersection with Beech Ridge Road North to the Robert Sainato property, currently bearing the tax map number 126.00-1-37; and
- iii Jennings Hill Road.
- b) The Highway Superintendent shall post such Town Highways with signage indicated such designation as soon as practical after the enactment of this local law in accordance with the rules and regulations of the New York State Department of Transportation and the manual of uniform traffic control devices
- c) A copy of this local law shall be filed in the Office of Parks, Recreation and Historic Preservation.

#### SECTION 3. Rules and Requirements

All persons traveling by snowmobiles on the above-designated town highways must:

a) Be at least 16 years of age or 10 years of age, if accompanied y an adult no less than 18 of age;

  - b) Wear a helmet at all times;
  - c) Operate only on the shoulder of the designated roads;
  - d) Operate only registered snowmobiles on the designated roads;
  - e) Operate such snowmobiles no faster than 20 miles per hour;
  - f) Be at least three inches of snow on the shoulder of the road;

### SECTION 4. When Effective

This local law shall take effect immediately upon filing with the Secretary of State's office.
