Over View of Comprehensive Plan – Peter Manning

Peter Manning is currently working on the Scenic Byway Extension plan for the Town of Lexington. There were some handouts that were given out and Lynn Byrne said that she had gotten the information from Nan Stolzenburg who was a consultant on the Town of Lexington Long Term Community Recovery Strategy of 2014. Peter Manning said that a comprehensive plan is a road map that looks at things like transportation, recreation, economic development, etc and it looks at where you are now and where you want to be in 5 to 10 years and how you are going to get there. Once you get updated information from the public then you look at it and move to realize the Towns' vision and after that you figure out how to implement it. The action plan is the list of items how you're going to get there and how much it might cost. The Comprehensive plan is a policy document and not a regulatory document. There are many benefits of doing a comprehensive plan or updating it. It helps with obtaining funding through grants, it lets people know what your community is about, and it attracts people to your community. Involve the public to get a general consensus. Peter Manning read from the NYS Town Law 272-a. Town Comprehensive Plan regarding the participation of citizens. The Town Board is the governing body in control of the comprehensive plan but can appoint a special committee. It takes an average of 18 months to complete. Mapping can affect the cost of the plan. The involvement of the public is key. Supervisor Berger said that we have a plan from 2003 but it needs to be looked at and updated and he asked if it would still take 12 to 18 months to complete.

Sean Mahoney - Website

Supervisor Berger started by saying that Donna Poulin was the Town's webmaster and with her passing, Sean may have a solution for the Town. Sean grew up in Lexington and currently lives in Hunter. He has an office in Kingston and employs 6 people. He has been doing this for 20 years. The short term solution is that he has access to the website and can make small changes and updates. His rate is \$85.00 per hour. The ipage website that is now in place is not ideal as it has some issues. It is not secure, it is not ada compliant and it is not mobile compatible. Local governments can be sued for not being ada compliant. The website could be set up to get alerts such as road closures, special meetings, legal notices, etc. Sean currently takes care of the website for the Town of Hunter. He would be able to submit a proposal for the Town of Lexington. Municipal websites are targets for hackers. Supervisor Berger asked about the Town email addresses and he also wanted to know what the cost would be. Sean said that a website that is ada compliant would be in the \$5,500.00 price range and ongoing costs would be updates 4 times a year at \$85.00 an hour and then the host would cost about \$180.00 per year. Lynn Byrne asked how editing is done and Sean said that he does a spell check and if it looks good then he will go ahead and post. He would want to know what is working what is not. He would train the Town Clerk to do updates like posting approved minutes.
