Establish a Standard Work Day for Elected and Appointed Officials

BE IT RESOLVED, that the Town Board be and hereby establishes the following as a standard workday for the Town Clerk, Tax Collector, Superintendent of Highways, Code Enforcement, and Highway employees for the purpose of determining days worked reportable to the New York State and Local Employee's Retirement System:

Standard six (6) hour day = one (1) day

Town Clerk, Tax Collector, Supervisor, Town Board Members, Bookkeeper, Justice, Attorney of Town, Assessor, Planning Board Members, Zoning Board of Appeals Members, Assessment Review Board Members, Health Officer, Historian, Dog Control Officer, Clerk to the Assessor, Clerk to the Town Court, Deputies to the Town Clerk, and Cleaning Personnel.

Standard five (5) day work week, eight (8) hour day = one (1) day Superintendent of Highways, Highway employees, and Code Enforcement Officer

On a motion by Council Member, Bradley Jenkins, seconded by Council Member, Bennett Wine the following was,

Therefore the Town Board of the Town of Lexington moves to accept the Standard Work Day for the Town Clerk, Tax Collector, Supervisor, Town Board Members, Bookkeeper, Justice, Attorney of the Town, Assessor, Planning Board Members, Zoning Board of Appeals Members, Assessment Review Board Members, Health Officer, Historian, Dog Control Officer, Clerk to the Assessor, Clerk to the Town Court, Deputies to the Town Clerk, Cleaning Personnel, Superintendent of Highways, Highway Employees, and the Code Enforcement Officer.

BE THEREFORE RESOLVED that the Resolution supersedes any other Resolution on this matter.

Highway Report

Superintendent of Highways Frank Hermance said that they had been out 13 times for snow. They have been doing a lot of garage work; service, brakes, universal, etc. and also cut up downed trees. He does not know what the CHIPS money will be for this year so he has not given a report of roads to be worked on yet. Supervisor, JoEllen Schermerhorn asked about the new truck and Frank Hermance said that he has it and it seems to work pretty good. He had the running boards put on that should have come with the truck, but he needs to put rear fenders on. Council Member Wine said that he noticed a section on Route 42 that looked like it was eroding, but that is a State Road.

Review Highway Regulations

Supervisor JoEllen Schermerhorn read aloud the purchasing policy for the Highway Department and Frank Hermance recommended that the policy spending amount be doubled for the Highway, which is currently \$1000.00. JoEllen Schermerhorn said that Frank knows what his budget is and with the higher cost of things \$2000.00 should be OK.

RESOLUTION # 25-20

Raise the amount of the purchase amount for the Highway Department

On a motion by Council Member, William Pushman and seconded by Council Member, Bradley Jenkins the following was,

Therefore this Town Board moves to change the purchase policy amount of \$1000.00 to \$2000.00 for the Highway Department.

Town Policies

Supervisor JoEllen Schermerhorn read aloud the reporting of accidents to persons, vehicles, property, & other people and no changes were made.

Frank Hermance said that Highway regulations should be changed.

JoEllen Schermerhorn read the policy regarding fuel, mileage, maintenance logs, & odometer readings. A log should be kept and submitted to the Town Board quarterly. Frank says all of the information is on his computer. Council Member Bradlley Jenkins said that the Comptrollers office looks for that information. JoEllen asked Frank what the windows on his computer is and he said he would check. Frank Hermance said that in the regulations we should go from oil & stone to motor pave. Council Member Bradley Jenkins said that all of the Highway regulations should be reviewed. Bradley and Frank said that they would go through to see what changes need to be made.

Frank mentioned that he is having a problem with "party houses" as they are parking on the roads. He had a problem getting through on Valley View Road where the cemetery is because there were 10 cars there. The Town does have a winter parking law but it is hard to enforce it. Council Member, Bennett Wine said that Air BNBS are a problem. Council Member Bradley Jenkins thinks that there might be a way for Frank to write the tickets but, Frank thinks the vehicles should be towed. Council Member William Pushman says that the owners should let people know how much parking there is when they rent out their houses. Supervisor JoEllen Schermerhorn said that Council Member Michael Barcone had looked into Air BNBS a couple of years ago and he will look at it again. Supervisor Schermerhorn said that she also had a copy of what the Town of Jewett has done regarding Air BNBS.

Code Enforcement Report

Town Board Members had copies to peruse.

Supervisors Meeting Summary

Supervisor, Schermerhorn attended the Supervisors' meeting along with Mike Barcone and they celebrated Jeff Flacks last meeting with CWC. They are working on getting a fly-car in Hunter to be stationed at the old Pete's Mobile. There will be a fly- car stationed in Prattsville at the new fire house. Jewett has put a law into effect regarding short term rentals. They talk about noise, garbage & refuse, parking/ offsite parking, trespassing, & animals being allowed to run at large. They will keep a folder of complaints and if they get too many for a certain property they will not renew the registration for the Air BNB. Council Member, Bradley Jenkins said that in the Town of Lexington there is a leash law but it is not enforced. Supervisor Schermerhorn said that the Town will be working on short-term rentals.

UPDATES:

<u>Website</u> – Supervisor Schermerhorn said that the Town has some proposals for the website and asked Council Member Bennett Wine to talk about it. Council Member Bennett Wine said that we had proposals ranging in price from \$2900-\$6000, but they really don't tell us very much. He has looked at the proposals but is not sure what we would be getting. He has asked other people to help him get

proposals and Kim McGalliard would be giving a proposal. There are all kinds of considerations to look at. A decision should be made at the March meeting.

<u>Bonnies' Trails-</u> Michelle Yost has turned in all of the necessary paperwork and we are looking at a grand opening in July around Bonnie's birthday. Supervisor Schermerhorn said that Bennett did a great job of marking trails.

<u>Comprehensive Plan</u>- The Town is waiting to hear from CWC regarding the \$20,000.00 grant. Hopefully we should find out in April.

<u>Farmers' Market</u> – They have applied for a grant for \$5000.00 and the Town is the lead agent. They are hoping to have a manager for the Farmers' Market. The Farmers' Market runs from May through October. They are hoping to run it every other Saturday and are looking to extend the hours a little. <u>Brook Char (trout)</u>- Michelle Yost is looking into alternate funding and Supervisor, Schermerhorn has talked to Judd Weisberg regarding this proposal and he is very excited about it.
