CHIPS Funding

The Town of Lexington will receive \$72,691.77 from the State in Chips money which is the same as last year. There is \$16,592.52 from Pave NY which is similar to last year. There is a total of \$89,284.29 to be used for paving.

The 2006 Ford Dump truck is in disrepair. The recommendation of the Highway Superintendent Frank Hermance is to purchase a new truck. He will put a spec out to see what we can get and check with the State contract as well. He also said that the 2011 pick up truck has a lot of miles on it.

Well Proposals for the Salt Shed

Supervisor Berger said he received proposals from Ives who uses a pounder which is preferred by the Board Members and a proposal from Titan who uses a drill. Ives proposed 124 feet with pump and casing at a cost of \$7,547.00 and Titan proposed 144 feet with pump and casing at a cost of \$6,700.00. Supervisor Berger is still waiting for a proposal from Aquatec so no decision was made.

Town Attorney Tal Rappleyea volunteered his services. Council Member JoEllen Schermerhorn said that she knows of a couple of people that would donate benches.
